We will not use the availability of any credit line you may have with us in determining whether your "Transfer From" Account listed on Page 1 has a sufficient balance for the authorized transfer. At our option and discretion, without further instruction from you, we may resume charging your "Transfer From" Account once all payments are current. If we do not resume charging your "Transfer From" Account we will notify you in writing that we have cancelled this Authorization. Cancellation of this Authorization does not excuse you from making timely payments under the terms of your loan.

Amendments and Termination: We will give you reasonable notice when we amend this Authorization. If this Authorization requires amending because of a change in State or Federal law, the change shall be effective immediately without notice. This Authorization will remain in effect until terminated in writing by any one of you or upon the maturity or payoff of the loan. We may terminate this Authorization by giving you written notice at the address of record for the loan. Any notice will be effective immediately when mailed or delivered by us. Notice to any one of you is notice to all of you.
